This is termed a "guide." Thus, it is not a definitive statement on proper Bankruptcy Procedure. Bankruptcy statutes, rules and procedures are extremely complex and subject to a variety of interpretations and applications.

- 2. "All Creditors" means: Everyone on the mailing matrix, parties in interest, plus any other attorney or objecting party who is not listed but might be a party in interest.
