3. Debts for Overpayment of Unemployment Benefits. If the papers disclose that the individual lived in the State of Oklahoma and received unemployment benefits during the three (3) years immediately preceding the commencement of this case, then copies of notices required to be mailed to all creditors under Fed. R. Bankr. P 2002 shall be sent to the following address:
